The ClucasGray Future Titans Prescient Fund has a flexible mandate to invest in a range of asset classes but will typically have high exposure to companies outside of the Top 40 Index. The fund is permitted to invest 25% offshore plus an additional 5% in Africa. The primary objective of the fund is to achieve real long-term capital growth ahead of CPI + 6%. The fund looks to acquire fast growing, mispriced, mid-and small-cap shares, "Future Titans", on the back of high conviction fundamental investment calls. The fund has a deep value / activist bias.

MONTHLY COMMENTARY

The ClucasGray Future Titans Prescient Fund was almost flat for the month with Grindrod, the funds largest holding, down 9% for the month on the back of flat earnings. Port and logistics volumes were up nicely for the period but margins were impacted by heavy flooding in Mozambique which caused significant delays and demurrage. Grindrod remains very cheap on a forward PE of 8x for a company with limited debt and holding monopolistic type assets. More importantly the company is best positioned for rail reform, where we await the announcement of the toll fee expected in October. As we have highlighted many times in the past, this reform has significant implications for Grindrod as rail has high barriers to entry and high margins. We expect Grindrod to announce the sale of further private equity assets which should release between R500 and R800m to be invested in rail assets

Hulamin was also down 20% after releasing results as the competitive issues prevents Hulamin management from detailing the capex program and benefits. This capex program will be completed in H2 2025 and we would expect earning in the R2 to R2.40 range for 2026. Importantly this lifts the R0E above the WACC which should unlock the 69% discount to NAV. Afrimat was down 15% for the month as Chinese steel producers warned on iron ore prices, but we remain excited about the Lafarge cement and quarries acquisition into an improving fixed investment cycle. The rest of the portfolio was broadly positive with the biggest percentage move coming from Renergen, where the company finally announced it had taken delivery of the LNG and Helium plant from the Chinese construction company. South Africa has an insatiable demand for LNG after Sasol announced the discontinuation of natural gas supplies to industrial customers and global demand for Helium remains strong for microchips and medical applications. Renergen needs to ramp up production as quickly as possible and we expect them to be at 70% of design output by December.

The Fund bought Southern Sun during the month as international tourism has continued to strengthen. Southern Sun is highly geared to higher occupancy on its five million bed nights where only three million were sold in 2023. A 1% increase in occupancy brings in R70m of revenue with little additional costs making them the best beneficiary of surging inbound tourism.


