Fund objective

Abax Equity Prescient Fund is a domestic fund with a mandate to invest in listed South African equities.

The Fund's primary objective is to outperform the FTSE/JSE Capped Shareholder Weighted Index (Capped SWIX TR) over the medium to long term on a net of fees basis. A secondary objective is to outperform the peergroup (as measured by the ASISA General Equity Unit Trust Mean).

The Fund has a high risk profile, and is suitable for long term investors seeking high levels of investment growth, who can tolerate the associated high levels of capital volatility.

About the Fund

The Fund is actively managed and draws upon Abax's valuation-based security selection process.

The Fund is managed by Anthony Sedgwick, Marius van Rooyen, Omri Thomas and Steve Minnaar.

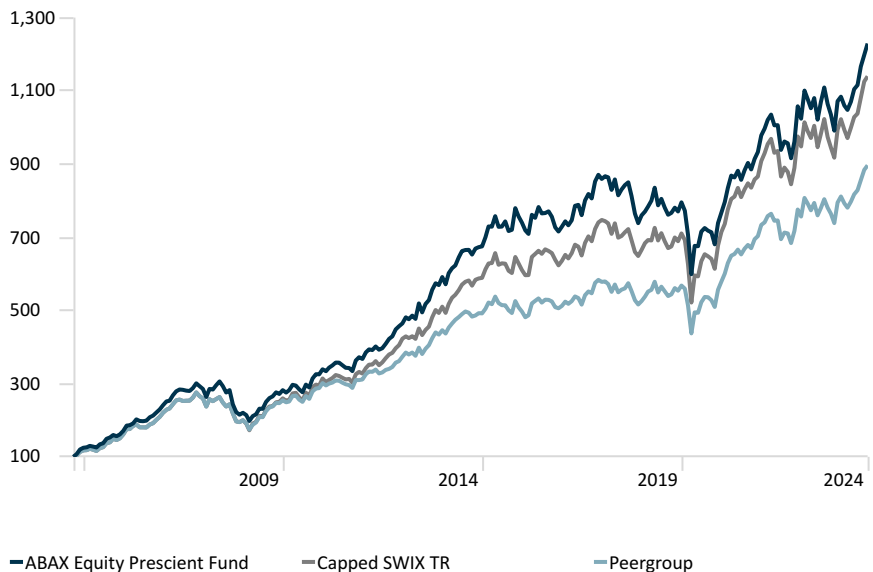

Investment growth since inception



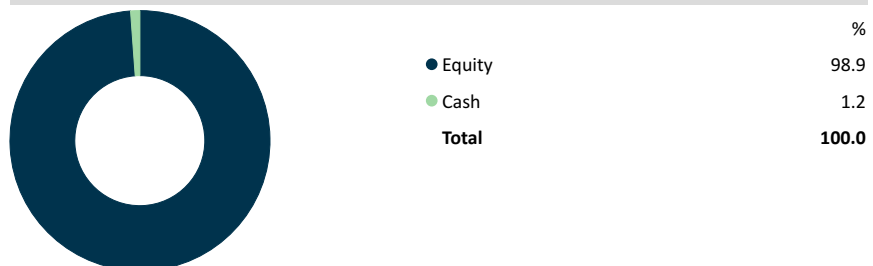

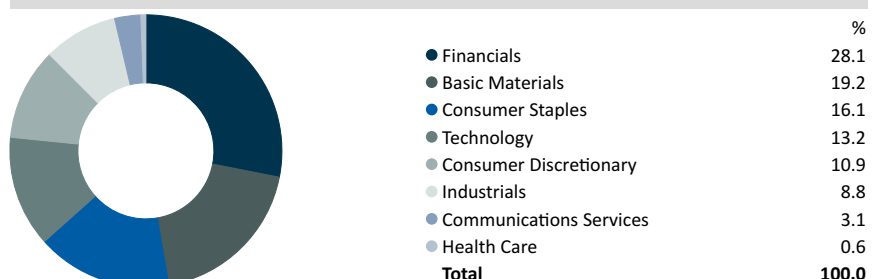

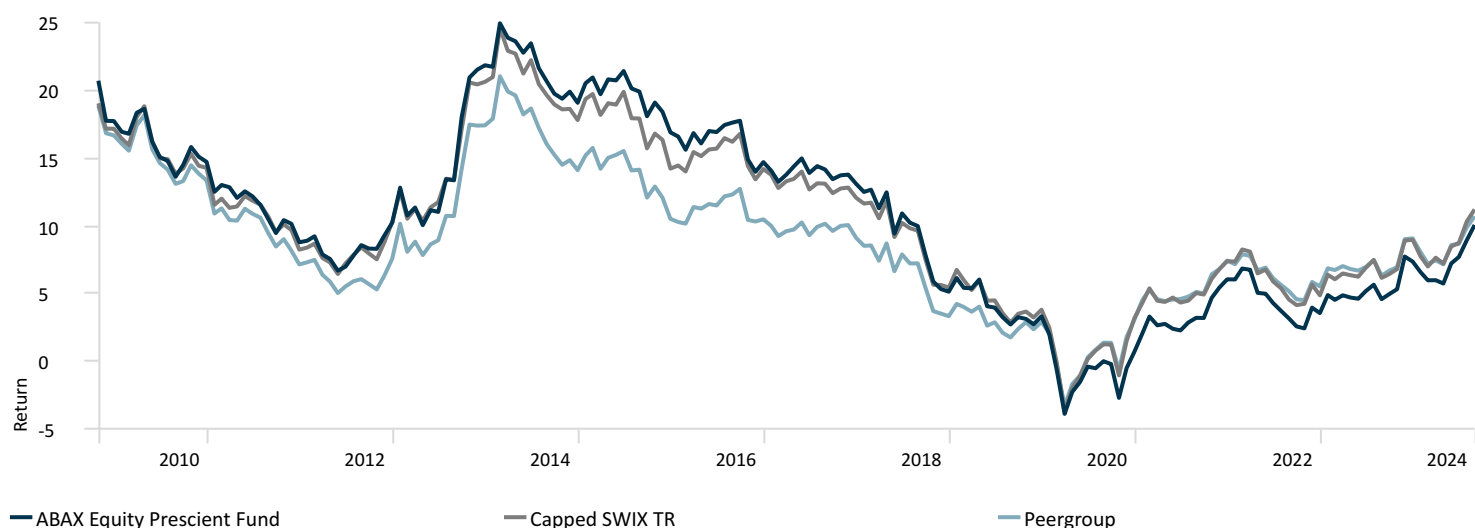

Definitions

Annualised performance - Annualised performance show longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return - The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV - The net asset value represents the assets of a Fund less its liabilities.

Sharpe Ratio - The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation - The deviation of the return stream relative to its own average.

Max Drawdown - The maximum peak to trough loss suffered by the Fund since inception.

Forward pricing is used. The Fund's Total Expense Ratio (TER) reflects the percentage of the average Net Asset Value (NAV) of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's. During the phase in period TER's do not include information gathered over a full year. Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER. Fund Performance has been calculated using net NAV to NAV numbers with income reinvested. The performance for each period shown reflects the return for investors who have been fully invested for that period. Individual investor performance may differ as a result of initial fees, the actual investment date, the date of reinvestments and dividend withholding tax. This is calculated daily as a percentage rate of the out-performance provided this out-performance has exceeded the previous maximum out-performance achieved. The percentage participation rate is 15%. Such fee is accrued daily and paid monthly where applicable. Full performance calculations are available from the manager on request. Prior to 2009 the Fund's performance benchmark was the ASISA South African General Equity Average.
