

Fund Profile

The Seed Global Prescient Feeder Fund is a Feeder Fund that only invests into the Irish domiciled Seed Global Fund. The Seed Global Fund is a multi-managed multi strategy Fund, where Seed is responsible for tactical asset allocation and strategy selection, with the focus on tilting the Fund to asset classes and geographies offering the most value. Manager selection is skewed towards owner managed investment firms with a consistent, repeatable process. The Feeder Fund aims to generate SOFR + 3% pa over rolling 5 year periods and avoid negative returns over any 5 year period. The net equity weighting will never exceed 75% of the Fund's market value. While an investment in the Feeder Fund provides investors with global exposure, the units are priced in rands.


