### Investment policy

The objective of this fund is to generate long-term capital growth and outperform the benchmark over a rolling three year period. The fund will have exposure to a broad range of markets across multiple asset classes, including both local and offshore investments. Underlying investments may include both actively managed and index-tracking strategies. The strategy is constructed with a medium allocation to equity.

The fund has adhered to its policy objectives as stated in the supplemental deed.

### Who this investment may be suitable for

This fund is suitable for investors who seek income and capital growth in the long term and an investment diversified across multiple asset classes. These investors are willing to withstand moderate levels of short-term market volatility.

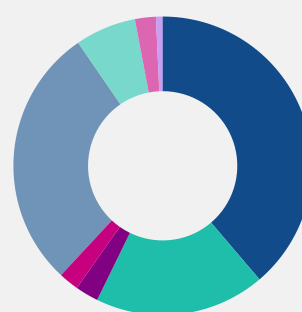

## Portfolio composition

There have been no material changes to the composition of the fund over the last quarter.

## Monthly market commentary

Despite a volatile period for financial markets in August, the month ended in positive territory across equity and fixed income. Global markets performed positively with developed equity gaining 2.64% over the month while Global Fixed Income gained 1.10%, both in USD terms. During the first half of August, 25bps interest rate hike by the Bank of Japan and weak economic data in the US led to equity markets and the USD selling off. Markets soon rebounded as US equities rallied later in the month due to strong retail sales and corporate earnings. Similarly, UK and European equities were also positive but lagged the US due to softening economic activity in the region. Fixed income assets performed well over the month as the market began to price in cuts over the coming months as CPI data showed continued easing of inflationary pressures. This month we see local equity underperforming their global counterparts with local equity gaining 1.34%, in ZAR terms. The Q2 GDP numbers came in strong at 0.4% increase (0.3% YoY) driven by stronger contributions from manufacturing, electricity, gas and water sectors which benefitted from the lack of load shedding. However, global markets registered stronger growth with OECD measure indicating 0.5% growth in Q2, overall Emerging Markets underperformed Developed Markets. This is with particular focus on China's weaker growth 0.5% growth in Q2 which makes up a large amount of South Africa's commodity exports. On the other hand, we saw local fixed income outperforming global fixed income, seeing gains of 2.35% over the month, in ZAR terms. A local driver of bonds' outperformance was the positive sentiment in the aftermath of the election results. The expected monetary easing by the South African Reserve Bank, in line with developed central banks was also supportive of rates decreasing over the month. Additionally, local fixed income was able to perform well on the back of a weaker US dollar. Finally, the Rand strengthened against USD in August closing at around 17.834R/\$ compared to R18.215/\$ in July.

## Important information

The collective investment scheme may borrow up to 10% of the market value of the portfolio to bridge insufficient liquidity. The ability of the portfolio to repurchase is dependent upon the liquidity of the securities and cash of the portfolio. A fund of funds is a portfolio that invests in portfolios of collective investment schemes that levy their own charges. This could result in a higher fee structure.

Lump-sum performance returns are being quoted. Income distributions, prior to deduction of applicable taxes, are included in the performance calculations. NAV to NAV figures have been used for the performance calculations, as calculated by the manager at the valuation time of 16:00 as defined in the deed, over all reporting periods. Investment performance calculations are available for verification upon request by any person. Reinvestment of income is calculated on the actual amount distributed per participatory interest, using the ex-dividend date NAV price of the applicable class of the portfolio, irrespective of the actual reinvestment date. The performance is calculated for the fee class. The individual investor performance may differ, as a result of initial fees, the actual investment date, the date of reinvestment and dividend withholding tax.

The rate of return is calculated on a total return basis, and the following elements may involve a reduction of the investor's capital: interest rates, economic outlook, inflation, deflation, economic and political shocks or changes in economic policy. Annualised returns are period returns re-scaled to a period of one year. This allows investors to compare returns of different assets that they have owned for different lengths of time. All period returns greater than one year have been annualised. Returns for periods less than one year have not been annualised. A cumulative return is the aggregate amount an investment has gained or lost over time, independent of the period of time involved. Actual annual figures are available to the investor on request. Illustrative investment performance is for illustrative purposes only.

## Glossary

**Annualised** - An annualised return is the weighted average compound growth rate over the period measured.

**Volatility** - Volatility (also called standard deviation) is a measure of how widely the returns varied over the period measured.

**Maximum drawdown** - A maximum drawdown is the maximum loss from a peak to trough of the portfolio over the period measured, before a new peak is attained.

**Sharpe ratio** - The Sharpe ratio is a measure of risk-adjusted returns. The Sharpe ratio reflects the extent to which an investment compensates for extra risk.

## What is the total investment charge (TIC)

Total expense ratio (TER) is the percentage of the value of the portfolio that was incurred as expenses relating to the administration (charges, levies and fees) of the portfolio. TER is calculated over rolling 3 years (or since inception, where applicable), and is annualised, to the most recent calendar quarter-end. A higher TER does not necessarily imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction costs (TC) is the percentage of the value of the portfolio that was incurred as costs relating to the buying and selling of the assets underlying the portfolio. Transaction Costs are a necessary cost in administering the portfolio and impacts portfolio returns. It should not be considered in isolation, as returns may be impacted by many other factors over time, including market returns, the type of financial product, the investment decisions of the investment manager, and the TER. Calculations are based on actual data, where possible, and best estimates, where actual data is not available. Total investment charges (TIC) is the percentage of the value of the portfolio that was incurred as costs relating to the investment of the portfolio. It is the sum of the TER and TC.
