

## Investment Objective & Strategy

The **WealthStrat Moderate Prescient Fund of Funds** will aim to deliver a moderate long term total return. The manager shall have limited flexibility in terms of asset allocation and shall not be precluded from continually varying the underlying exposure to both local and offshore assets. The Fund will employ asset and limited geographical allocations to reflect changing economic and market conditions to maximise returns over the long term, the **WealthStrat Moderate Prescient Fund of Funds** will, apart from assets in liquid form, consist solely of participatory interest in Collective Investment Schemes which will invest in a diversified mix of assets, including but not limited to equities, property, preference shares, money market and fixed interest instruments. The equity allocation will be managed at a maximum effective exposure, including offshore equity, up to 60%. The underlying collective investment schemes are permitted to invest in listed and unlisted financial instruments in line with conditions as determined by legislation from time to time. The underlying portfolios will predominantly invest in South African markets but is however permitted to include investments in offshore jurisdictions subject to the investment conditions determined by legislation from time to time.

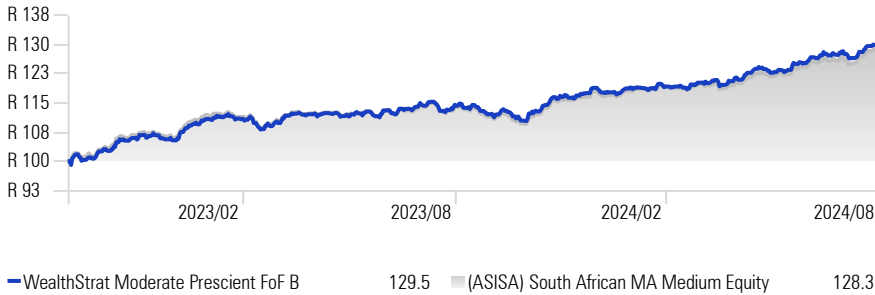

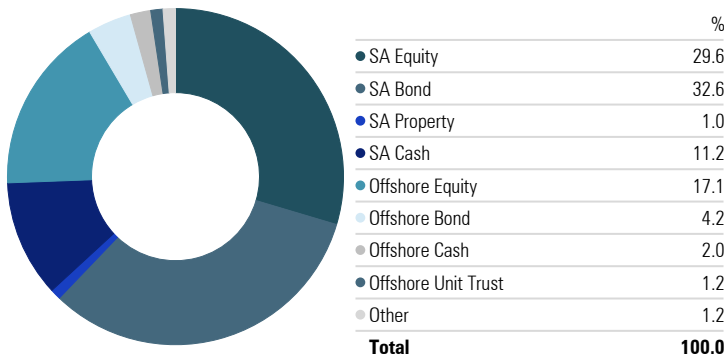

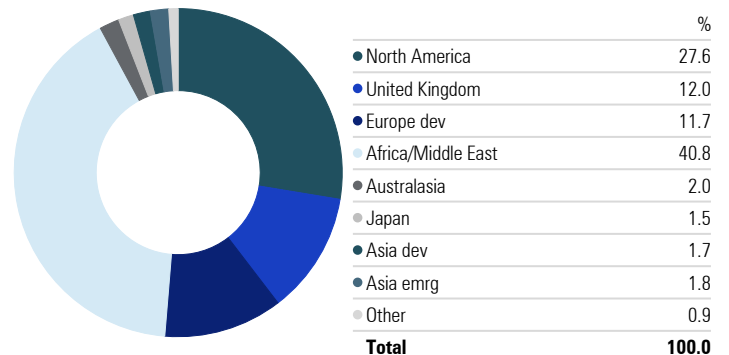
## Asset Allocation

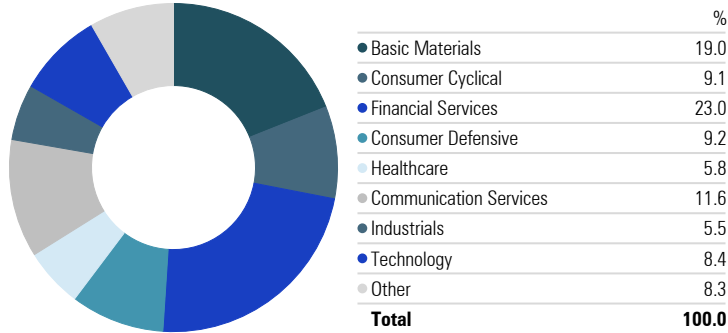

## Quarterly Fund Commentary

Moderate investors generated decent returns in the second quarter of 2024, as most risk assets recorded robust performance. Strong returns from local equities acted as a tailwind to the performance of the portfolio over the quarter. In addition, the strong performance from local bonds added to the performance of the portfolio over the quarter.

The WealthStrat Moderate Prescient Fund of Funds returned +4.2% for the quarter and has generated a return of +10.8% over the past year.

The portfolio remains diversified in terms of its exposure to various asset classes, and we remain confident in its ability to deliver inflation-beating returns over the long term, independent of the market environment.

### Asset Allocation

Local bonds make up the bulk of the asset allocation within the portfolio. This includes allocations to corporate, government and inflation-linked bonds. Short dated nominal bonds held up well over the quarter and produced a stable performance, however, they lagged longer duration peers. Longer-dated instruments ended the quarter higher, producing their second-best Q2 return in 22 years, ahead of global peers. Yields moved lower this quarter (and prices higher), as bonds were beneficiaries of foreign inflows on the back of the SA election risk subsiding. Local equities and in particular "SA Inc." stocks moved higher this quarter, as a relief rally drove risk assets higher. This was largely driven by the Financials (+17.8%) sector, which rebounded strongly from the poor performance recorded in the first quarter of 2024. Large banking and insurance counters produced double digit returns on the back of general strength in the sector. Capitec (+27.4%), Firststrand (+24.6%), Sanlam (+23.5%) and Standard Bank (+18.5%) were among the best performing counters in the sector over the quarter. Industrials (+5.2%) ended the quarter in positive territory, largely driven higher by "SA Inc." shares and in particular food and apparel retailers, which rebounded strongly. On the other hand, rand hedges and companies that earn a large portion of their revenue outside of South Africa produced poor returns over the quarter. Resources (+3.6%) ended the quarter higher, however, the sector lagged the broad market rebound. The performance was largely driven by diversified miners as well as gold and platinum counters including Anglo American PLC (+23.9%), Impala Platinum (+15.9%) and Anglo Gold Ashanti (+8.8%). Global equities produced mixed returns this quarter, with stocks related to artificial intelligence (AI) leading the way higher. The US moved higher this quarter, largely driven by stocks related to AI. Turning to other developed market regions, it was a mixed picture, with Europe (in particular Germany) and Japan producing negative returns, whilst on the other hand, the UK posted a strong return. Local cash allocations continue to deliver positive returns this quarter. Offshore bond and cash allocations detracted from performance on the back of news from the major central banks that interest rate cuts will be later and shallower than previously expected, which caused yields to move higher, providing a headwind for fixed income asset classes. The firm rand acted as a headwind to the performance of offshore allocations. A small allocation to local listed property contributed to performance this quarter, as the property sector continued its strong run, driven by SA focused property counters including index heavyweights Growthpoint (+13.9%) and Redefine (+7.5%). The fund's asset allocation is broadly similar to the previous quarter.

### Fund Selection

The contribution from fund selection was mostly positive for the quarter.

Amplify SCI Strategic Income delivered strong performance over the quarter, providing returns that were in the first quartile relative to income fund peers. The fund was well-positioned for the strong local bond market that was seen during the quarter and benefitted from a longer duration position than some of its income fund peers. SA markets rallied during the quarter on the back of the perceived market friendly outcome of the national election, which led to the formation of a centrist coalition and a government of national unity (GNU). The SA bond market remained sensitive to news flow surrounding the outcome of the SA election over the quarter, with yields moving significantly up and down depending on the likely outcome. Yields rallied across the SA nominal yield curve during the quarter, pushing prices higher and resulting in positive outcomes for fixed income investors.

Truffle SCI General Equity produced first quartile performance, ahead of the category. The fund's exposure to SA financials and SA retailers rebounded this quarter, as SA Inc. stocks participated in a relief rally. This includes Firststrand (+24.6%), Absa (+12.3), Capitec Bank (+27.3) and The Foschini Group (+28.1%). On the other hand, the fund's exposure to rand hedges and certain platinum and gold counters including, Anheuser-Busch InBev (-6.9%), Anglo American Platinum (-21.7%) and Gold Fields (-10.0%) detracted from the fund's performance.

Nedgroup Investments Core Global FF delivered performance ahead of the peer group over the quarter, however, the fund delivered a negative absolute return. Global equity markets delivered mixed performance over the quarter, with US equities (and particularly US technology companies) ending the quarter significantly higher, while European (excluding UK), Japanese and Chinese equities ended the quarter in the red. Global bonds ended the quarter lower, as the market continues to be very sensitive to news on inflation and the prospects for interest rates. Additionally, the South African Rand's strength acted as a headwind to the performance over the quarter, as the local unit was firmer against the major developed market currencies, benefiting from a market friendly outcome in the SA elections.

There were no changes made to the underlying funds in the portfolio in the second quarter.

### Summary

We are pleased that the portfolio managed to deliver a decent return over the second quarter in a strong local environment. We remain comfortable with the positioning of the portfolio, both from an asset allocation and a manager selection perspective. The portfolio continues to be allocated to a diverse range of attractively priced local and global asset classes and we are confident that it will be able to deliver on its objective over the long term. The fund has adhered to its policy objective.

**Glossary**

**Annualised performance:** Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest return:** The highest and lowest returns for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Max Gain:** Largest increase in any single month

**Fund Specific Risks**
