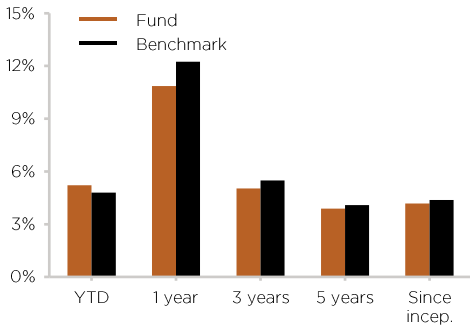
Risk Indicator Definition

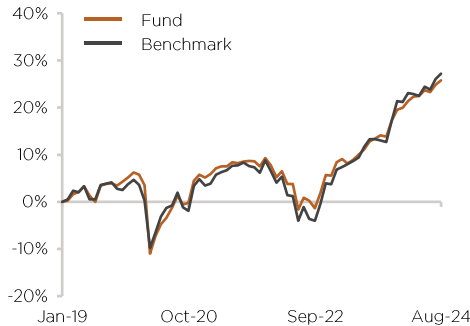
RISK INDICATOR

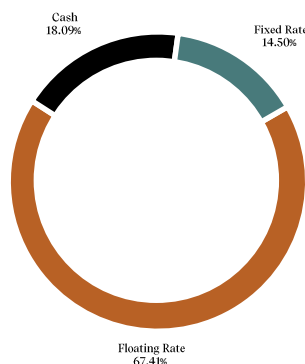

MARKET COMMENTARY

Market Dynamics:

Global credit markets followed global risk weaker at the beginning of August, with the benchmark iTraxx XOver 5 year spread selling off aggressively from 294 basis points (bps) to an intra-month high of 343 bps over the first three trading days of the month. This is in response to the extreme volatility witnessed in the Nikkei 225, which wilted some 2.5%, 5.8% and 12.4% over the first three trading days. The contagion hit European equities and credit alike and it was only risk-free government securities that managed to hold any value during the period. Things quietened down over the rest of the month with some normality returning to risk markets. The Nikkei recouped most of its losses, ending the month only some 1.1% lower, while the Euro Stoxx 50 posted a positive gain of 1.75% and the Dow Jones delivered 1.76% in USD.

The rebound was also felt by global credit, with the iTraxx XOver rallying back to end the month at a spread of 288 bps. In total return terms, the benchmark delivered 0.88%, comfortably beating cash.

Two credit events were reported during August. The first was Atos, a European IT company specialising in various aspects of the broad software industry with a well-diversified product base. This name is found only in iTraxx XOver Series 40, so it will have a minimal effect on the fund. Arguably, any losses have been largely discounted already, so we feel rather comfortable with the current positioning. Avon Products was the second high-profile credit event after it filed for Chapter 11 bankruptcy in response to allegations and potential US lawsuits that some of its products were potentially a health risk. Avon Products went from being a component of the CDX North American Investment Grade Index Series 23 which was constituted in 2014. It was downgraded to sub-investment grade and moved to the CDX NA High Yield Index in March 2015, and it remained in the High Yield Index until dropping out of Series 41 in September 2023. The recovery auction has been set for the 24th of September. The fund has no exposure to Avon Products.

The fund generated 0.74% on an after-all fees basis, underperforming the index by around 0.14%. We are currently positioned in a defensive manner and look to up-risk the fund once the iTraxx XOver spread breaches the 350 bps. In the interim, we will continue to look out for low-market risk, high-yielding opportunities.



Glossary

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Sortino Ratio: A measure of the risk-adjusted return of a portfolio. It is a modification of the Sharpe ratio but only penalises the returns falling below a user specified target, or required rate of return, while the Sharpe ratio penalises both upside and downside volatility equally.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

High Water Mark: The highest level of performance achieved over a specified period.

Total Expense Ratio (TER%): The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

Performance fee incl. in TER (%): The Performance Fee is a payment made to the Fund Manager for generating outperformance and is generally calculated as percentage of outperformance, often both realized and unrealized.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

Total Investment Charges TIC (%) = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).

Specific Risk

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
