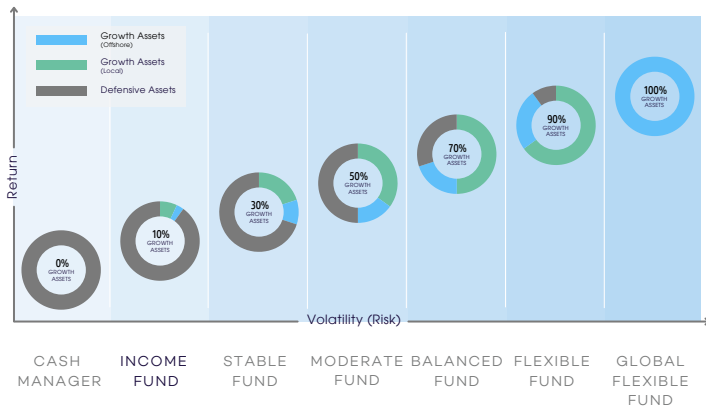

Risk and Return Profile



Risk profile is the appropriate level of investment risk having regard to the investor's risk required, risk capacity and risk tolerance.

Fund Objective and Strategy

The fund will aim to provide a high level of income and medium to long-term capital growth with a targeted real return of 1%. The fund has a low risk profile, and is suitable for long term investors seeking low levels of investment growth, who can tolerate the associated low levels of capital volatility.

The portfolio adhered to its investment objectives and there were no material changes to the composition of the portfolio, during the reporting period.

Collective Investment Schemes in Securities (CIS) should be considered as medium to long-term investments. The collective investment scheme may borrow up to 10% of the market value of the portfolio to bridge insufficient liquidity. A schedule of fees, charges and maximum commissions is available on request from the Manager. There is no guarantee in respect of capital or returns in a portfolio. A CIS may be closed to new investors in order for it to be managed more efficiently in accordance with its mandate. CIS prices are calculated on a net asset basis, which is the total value of all the assets in the portfolio including any income accruals and less any permissible deductions (brokerage, STT, VAT, auditor's fees, bank charges, trustee and custodian fees and the annual management fee) from the portfolio divided by the number of participatory interests (units) in issue. Forward pricing is used. The Fund's Total Expense Ratio (TER) reflects the percentage of the average Net Asset Value (NAV) of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's. During the phase in period TER's do not include information gathered over a full year. Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

A Fund of Funds is a portfolio that invests in portfolios of collective investment schemes, which levy their own charges, which could result in a higher fee structure for these portfolios.

DEFAULT RISK: The risk that the issuers of fixed income instruments (e.g. bonds) may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Glossary

- **% POSITIVE MONTH:** The percentage of months since inception where the Fund has delivered positive return.
- **ALPHA:** Denoted the outperformance of the fund over the benchmark.
- **ANNUALISED PERFORMANCE:** Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.
- **AVERAGE CREDIT QUALITY:** The weighted average credit quality of all the underlying interest bearing instruments in the Fund (internally calculated).
- **AVERAGE DURATION:** The weighted average duration of all the underlying interest bearing instruments in the Fund.
- **DIVIDEND YIELD:** The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.
- **HIGH WATER MARK:** The highest level of performance achieved over a specific period.
- **HIGHEST & LOWEST RETURN:** The highest and lowest returns for any 1 year over the period since inception have been shown.
- **MAX DRAWDOWN:** The maximum peak to trough loss suffered by the Fund since inception.
- **MAX GAIN:** Largest increase in any single month.
- **NAV:** The net asset value represents the assets of a Fund less its liabilities.
- **PE RATIO:** The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.
- **SHARPE RATIO:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.
- **STANDARD DEVIATION:** The deviation of the return stream relative to its own average
