FUND PROFILE

The Mentenova Local Equity Prescient Fund of Funds is an actively managed local equity fund of funds. The fund will be actively managed with exposure to local equities to maximize returns for investors. Given the risk profile, an investment horizon of more than 5 years is required.

INVESTMENT OBJECTIVE

The objective of the Fund is to outperform its benchmark on a total return basis in a cost-effective manner. The above fund adhered to the investement policy objectives as stated in the Supplemental Deeds.

INVESTMENT UNIVERSE

The Fund will invest in an optimally diversified number of funds blended using Mentenova's proprietary portfolio construction process to achive its objective. The portfolio construction will involve a focus on only local equity opportunities subject to the investment conditions determined by legislation from time to time.








PORTFOLIO EQUITY HOLDINGS




TOP EQUITY HOLDINGS (LOOK THROUGH) (%)
