Abax SA Income Prescient Fund is a domestic fund with a flexible mandate to invest across a wide range of local fixed income asset classes.

The Fund's primary objective is to maximize income returns and provide relative capital stability.

**About the Fund**

The investment team will invest in a diversified portfolio of bonds, fixed deposits, structured money market instruments, listed debentures and other high yielding securities. The duration typically ranges from 0-2 years. We will increase duration when opportunities arise, but usually prefer to manage the strategy with a relatively low level of interest rate risk.

The Fund is managed by Philip Liebenberg and Lara Dalmeyer.

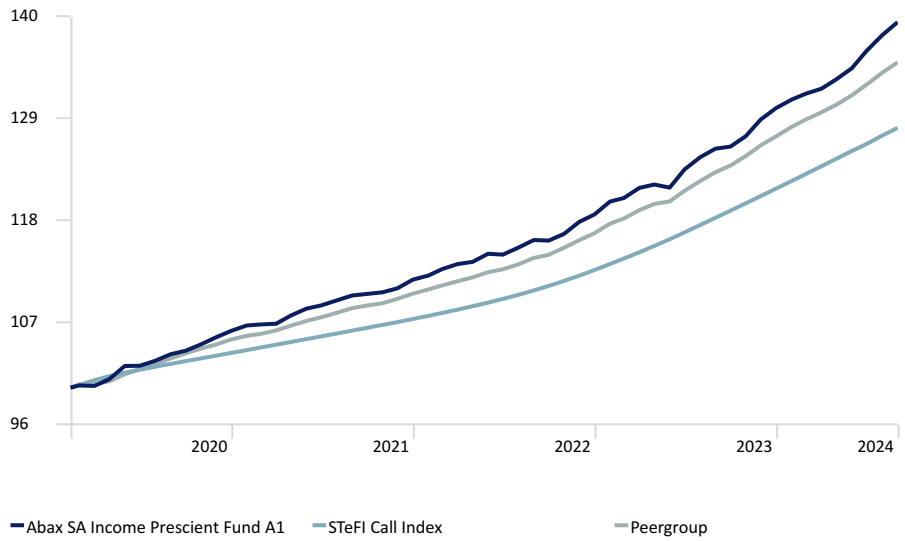

**Investment growth since inception**



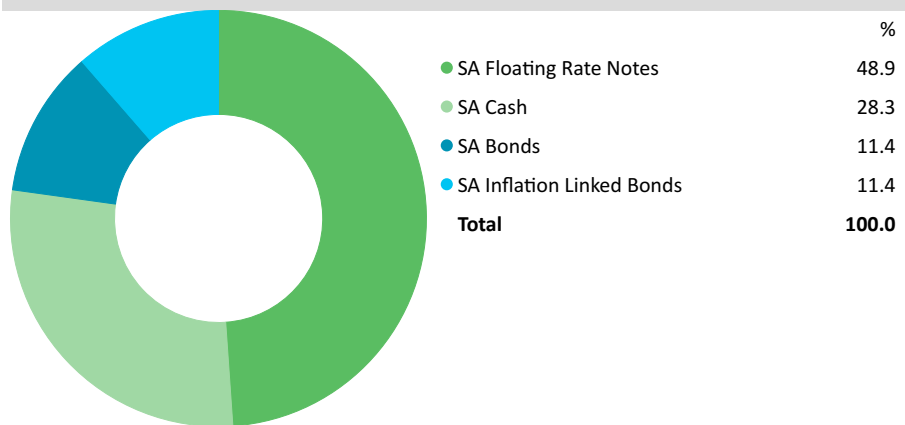

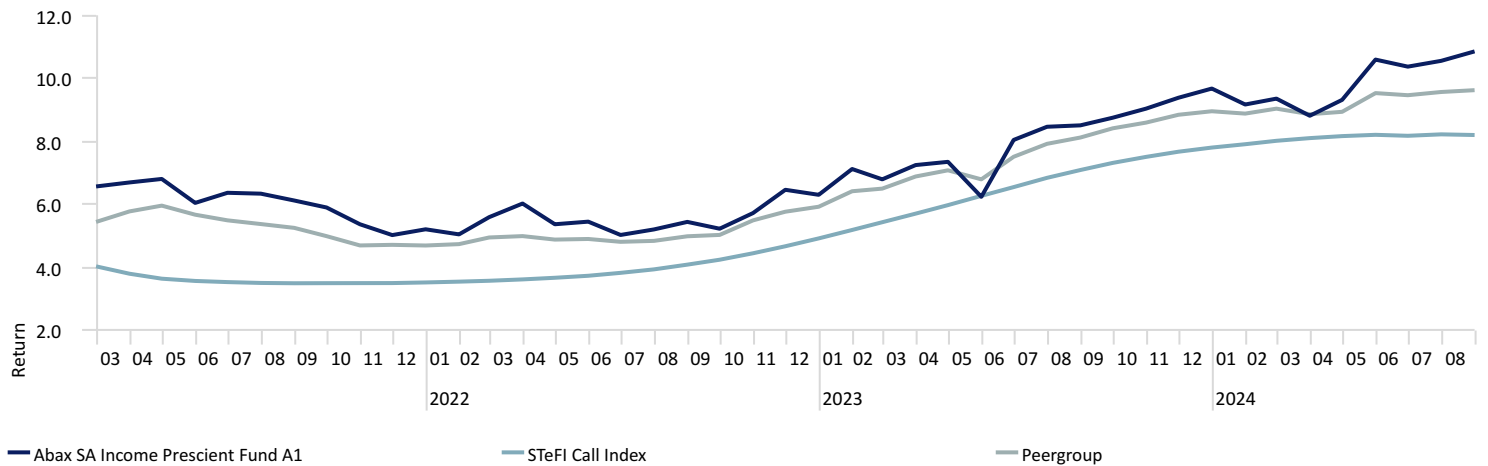

**Annualised performance** - Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest return** - The highest and lowest returns for any 1 year over the period since inception have been shown.

**NAV** - The net asset value represents the assets of a Fund less its liabilities.

**Sharpe Ratio** - The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Standard Deviation** - The deviation of the return stream relative to its own average.

**Max Drawdown** - The maximum peak to trough loss suffered by the Fund since inception.
