



FUND COMMENTARY

Looking at SA asset classes, the Capped Swix was up 1.29% in August, SA Property was up 8.37%, with the All Bond Index up, 2.38%. Offshore asset classes, the MSCI All Country World Index was up 2.54%, Offshore Property was up 6.26%, with Offshore Bonds also up, 2.36% (All these returns are in US Dollars).

Year to date, the Rand has strengthened by approximately 2.6% versus the USD. Looking at 1 year returns to the end of August 2024, Offshore equities have dominated Local equities, with Offshore property, SA property and SA fixed income producing healthy double digit returns.

GLOSSARY

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any I year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.
