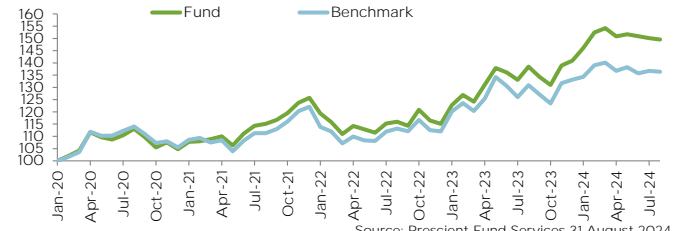



FUND OBJECTIVE & STRATEGY

The Fund will employ asset and geographical allocations to reflect changing economic and market conditions to maximise returns over the long term.

MONTHLY COMMENTARY

The month kicked off with two significant economic events that set the tone for global markets. First, there was disappointing economic data from the United States, and second, the Bank of Japan (BOJ) raised interest rates - a rare move in recent years.

The ISM Manufacturing Index came in well below expectations, registering at 46.8. Additionally, July's job numbers were lackluster, with only 144,000 jobs added - the lowest figure in three years. These developments sparked concerns that the US might be heading toward a recession. Some even speculated about the possibility of an emergency rate cut by the Federal Reserve (Fed). The BOJ increased its policy rate for only the second time in the past 17 years. This move led to the unwinding of carry trade positions, impacting global markets.

Early in the month, there was a selloff, and the MSCI All Country World Index (ACWI) retreated by 6.38%. On August 5th, the Japanese market (TOPIX) experienced a sharp decline of 12.23%, the largest daily drop since Black Monday in 1987. As the month progressed, investors adjusted their expectations for more aggressive rate cuts by the Fed. Consequently, the MSCI ACWI rebounded, closing the month with a positive return of 2.54%. Interest rate-sensitive assets performed well, with global bonds gaining 2.40% and global real estate investment trusts (REITs) rising by 6.20%.

Value stocks outperformed growth stocks during the month. Developed market equities fared better than emerging market equities. The US led the way, with the S&P 500 posting a gain of 2.38%. Other notable performances included the MSCI Asia ex-Japan index (+1.98%) and the MSCI Emerging Markets index (+1.61%). The UK's FTSE gained 0.45%, while European markets (excluding the UK) rose by 1.98%. Japan's TOPIX recovered somewhat from its earlier drawdown, closing down 2.90% for the month.

Weaker global growth and manufacturing data put pressure on commodity prices. Brent crude oil prices declined by 5.51%, reaching \$75.05 before recovering slightly to \$78.57 by month-end. The ongoing Chinese real estate crisis continued to impact iron ore prices, pushing them to a two-year low.

Our top performing shares during the month were PayPal, Meta Platforms and Berkshire Hathaway with the biggest detractors being Emerson Electric, Samsung and Starwood

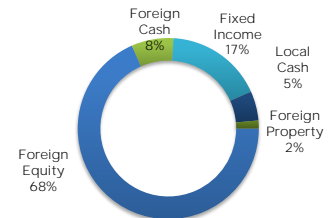

Collective Investment Schemes in Securities (CIS) should be considered as medium to long-term investments. Forward pricing is used.

The Fund's Total Expense Ratio (TER) reflects the percentage of the average Net Asset Value (NAV) of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's. During the phase in period TER's do not include information gathered over a full year.

Transaction Costs(TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

Where a current yield has been included for Funds that derive its income primarily from interest bearing income, the yield is a weighted average yield of all underlying interest bearing instruments as at the last day of the month. This yield is subject to change as market rates and underlying investments change.

The Manager retains full legal responsibility for any third-party-named portfolio. The investor acknowledges the inherent risk associated with the selected investments and that there are no guarantees. A list of fund specific risks is provided below. Please note that all documents, notifications of deposit, investment, redemption and switch applications must be received by Prescient by or before 13:00 (SA), to be transacted at the net asset value price for that day. Where all required documentation is not received before the stated cut off time Prescient shall not be obliged to transact at the net asset value price as agreed to. Funds are priced at either 3pm or 5pm depending on the nature of the Fund. Prices are published daily and are available on the Prescient website.

Performance has been calculated using net NAV to NAV numbers with income reinvested. The performance for each period shown reflects the return for investors who have been fully invested for that period. Alpha: Denoted the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Months: The percentage of months since inception where the Fund has delivered positive returns.

Equity investment risk: Value of equities (e.g. shares) and equity-related investments may vary according to company profits and future prospects as well as more general market factors. In the event of a company default (e.g. bankruptcy), the owners of their equity rank last in terms of any financial payment from that company.
